To take advantage of our "LPH", complete and return this form along with **\$35.00** before your payment(s) are due to Chattahoochee Federal Credit Union, P.O. Box 8, Valley, AL 36854-0008.

With our Loan Payment Holiday (LPH) you pay a **\$35.00** fee per loan to skip only one month of payments between 11/01/2020 and 1/31/2021 on each loan, allowing you extra money when you need it most.

By signing below, you and any joint owner, authorize CFCU to extend our loan repayment terms. The interest on your loan(s) will continue to accrue on the principal loan amount and will be calculated upon next payment. All other terms and provisions will remain unchanged. Any payments made through payroll deduction or direct deposit will be redirected to your share account. You simply make your skipped payment(s) at the end of your loan term(s).

**In order to qualify for this skip payment, you must be a member in good standing and have made at least three (3) months of consecutive payments on your loan(s). Loans with extension agreements or modifications in the last twelve (12) months are not eligible for this offer. Loan account(s) must be current. Request must be received five days prior to due date. Loans with reoccurring payments will be posted to savings account.**

The processing fee will be automatically deducted from your share account if available. If not available, request will not be honored unless the \$35.00 processing fee is received.

**Christmas, Back to School, Vacation loans and Fast Cash loans are not eligible for LPH.**
